

## **Privacy Notice for Retrofit Action Plan consultation survey, Housing Services**

This privacy notice was completed in October 2022 and will be regularly reviewed. When we use your personal data, CYC complies with data protection legislation and is the registered 'Controller'. Our data protection notification is registered with the Information Commissioner's Office (ICO) – reference **Z5809563**.

### **Why is information being collected?**

To carry out a consultation on the council's plans for energy efficient retrofit of homes in the City, and understand views of residents, stakeholders and suppliers.

### **What information will be collected?**

We are collecting

- your name and details of any organisational affiliation as the rest of the survey has questions that are relevant to some organisations
- your opinions and thoughts / your feedback

### **What will we do with the information?**

We are using the information you give us with your consent. You can withdraw your consent at any time by contacting Housing Standards [betterhomes@york.gov.uk](mailto:betterhomes@york.gov.uk)

The information we collect will be included in presentations, statistics and reports. Any presentations, reports and statistics for publication or use outside of the authorised council staff, will be anonymised and cannot be linked back to you, your family or individuals. Reports containing anonymous information may also be shared with the general public and other organisations.

If you have completed a paper survey, once you complete and return it to us, we will transfer the information you have given us onto the council's secure network and then destroy confidentially the paper copy.

We will not use the information for any other purpose than set out in this privacy notice and will not disclose to a third party i.e. other companies or individuals, unless we are required to do so by law for the prevention of crime and detection of fraud, or, in some circumstances, when we feel that you or others are at risk.

### **Storage of information**

We will keep the information you give us in CYC's secure network drive and make

sure it can only be accessed by authorised staff.

### **How long will we keep the information?**

We will keep the information you give us for up to three years and then will securely and confidentially destroy it.

Where required or appropriate, at the end of the retention period we will pass onto the City Archives any relevant information.

### **Further processing**

If we wish to use your personal information for a new purpose, not covered by this Privacy Notice, we will provide you with a new notice explaining the purpose prior to commencing the processing and the processing conditions. Where and whenever necessary, we will seek your consent prior to the new processing.
