

Privacy Notice for blue badge city centre parking consultation

This privacy notice was completed in April 2021 and will be regularly reviewed. When we use your personal data, CYC complies with data protection legislation and is the registered 'Controller'. Our data protection notification is registered with the Information Commissioner's Office (ICO) – reference **Z5809563**.

Why is information being collected?

This consultation asks Blue Badge holders for their views on potential new car parking bays to improve access to the city centre. This will help us to understand whether creating the proposed parking will improve access to the city centre. While we are not collecting any personal data which could lead to any individual being identified, we do want to understand the diversity of views we are collecting so that we can make extra effort to encourage views from unrepresented groups– for example a type of disability or an age range.

What information will be collected?

We are collecting:

- Postcode
- Age
- Type of disability
- Whether the respondent is a blue badge holder or a carer of a Blue Badge Holder
- We will then show a number of potential new places for Blue Badge parking and ask questions about the locations, types of bays and other options at each location.

Participation is voluntary and you can choose to not answer any of the questions.

What will we do with the information?

We are using the information you give us with your consent. You can withdraw your consent at any time by contacting the transport team on highway.regulation@york.gov.uk

The information we collect will be included in presentations, statistics and reports. Any presentations, reports and statistics for publication or use outside of the authorised council staff, will be anonymised and cannot be linked back to you, your family or individuals. Reports containing anonymous information may also be shared with the general public and other organisations.

We will protect it and make sure nobody has access to it who shouldn't and we will not keep it for longer than is necessary.

If restrictions allow, we will offer paper copies. If you have completed a paper survey, once you complete and return it to us, we will transfer the information you have given us onto the council's secure network and then destroy confidentially the paper copy.

We will not use the information for any other purpose than set out in this privacy notice and will not disclose to a third party i.e. other companies or individuals, unless we are required to do so by law for the prevention of crime and detection of fraud, or, in some circumstances, when we feel that you or others are at risk.

Storage of information

We will keep the information you give us in CYC's secure network drive and make sure it can only be accessed by authorised staff.

How long will we keep the information?

We will keep the information you give us for up to three years and then will securely and confidentially destroy it.

Where required or appropriate, at the end of the retention period we will pass onto the City Archives any relevant information.

Further processing

If we wish to use your personal information for a new purpose, not covered by this Privacy Notice, we will provide you with a new notice explaining the purpose prior to commencing the processing and the processing conditions. Where and whenever necessary, we will seek your consent prior to the new processing.
