# Privacy Notice for the Statutory Consultation of Additional Licensing

This privacy notice was created in April 2021 and updated in September 2021 and we will keep it under regular review. When we use your personal data, City of York Council (CYC) complies with data protection legislation, and is the registered 'Controller'. Our data protection notification is registered with the Information Commissioner's Office (ICO) – reference Z5809563.

# Why is information being collected?

We do this in order to comply with section 56 of the Housing Act 2004 by carrying out a10 week consultation with all those who may be affected when we are considering a designation for additional licensing of HMOs. We may also need to carry out further consultation where it is necessary to allow people who are likely to be affected by the proposals another opportunity to make further comments.

We only use your personal data with your explicit and informed consent for the purposes described in this privacy notice. # What information will be collected?

We will collect your feedback and opinions through an online survey and/or a virtual workshop about whether to introduce an Additional Licensing Scheme

# What will we do with the information?

The information we collect will be included in reports and will be used to shape the Additional Licensing Scheme should one be designated.

We will never use your personal information in any reports, as they will be anonymised and will not identify any individuals. Reports containing anonymous information may also be shared with the general public and other organisations.

We will not use the data for any other purpose than stated and will not disclose to a third party i.e. other companies or individuals, unless we

are required to do so by law for the prevention of crime and detection of fraud, etc.

We will use Zoom for the virtual workshops and we are currently using Zoom Video Communications Inc Pro or Business version ("Zoom") for that purpose. Where meetings are recorded, recordings will be kept locally on our server and will not be retained by Zoom. Some personal data, such as user's names, email addresses; telephone numbers where applicable, IP address, MAC address, other device ID (UDID), device type, operating system type and version, client version, type of camera, microphone or speakers, connection type, etc. will be stored securely on Zoom's system in the US ( that is, outside the EEA) in compliance with the EU – US Privacy Shield Framework. Zoom does not sell personal data to third parties; collects only the personal data required to provide Zoom services; and retains that data only for so long as is necessary for the provision of those services. ### Storage of information

We will keep the information you give us in CYC's secure network drive and make sure it can only be accessed by authorised CYC staff. ### How long will we keep the information?

We will keep the information you give us for up to three years and then we will destroy it. Where required or appropriate to, at the end of the retention period, we will pass onto the City Archives any relevant information.

### **Further Processing**

If we wish to use your personal data for a new purpose, not covered by this Privacy Notice, we will provide you with a new notice explaining the purpose prior to commencing the processing and the processing conditions. Where and whenever necessary, we will seek your consent prior to the new processing.
