

Privacy Notice for Heworth Without MUGA Survey

This privacy notice was completed in November 2022 and will be regularly reviewed. When we use your personal data, CYC complies with data protection legislation and is the registered 'Controller'. Our data protection notification is registered with the Information Commissioner's Office (ICO) – reference **Z5809563**.

Why is information being collected?

We are conducting this survey to invite residents and interested parties to give us their views on the proposals for a Multi Use Games Area to be installed within the Heworth Without Ward.

We ask some personal information to gain insight into the needs of particular communities and to ensure we are a fair and inclusive service provider.

What information will be collected?

We will collect information about you and your household, including age, postal code and also your opinions on the plan.

Participation is voluntary and you can choose to not answer any of the questions.

What will we do with the information?

We are using the information you give us with your consent. You can withdraw your consent at any time by contacting laura.redhead@york.gov.uk

The information we collect will be included in presentations, statistics and reports. Any presentations, reports and statistics for publication or use outside of the authorised council staff, will be anonymised and cannot be linked back to you, your family or individuals. Reports containing anonymous information may also be shared with the general public and other organisations.

We will protect it and make sure nobody has access to it who shouldn't and we will not keep it for longer than is necessary.

If you have completed a paper survey, once you complete and return it to us, we will transfer the information you have given us onto the council's secure network and then destroy confidentially the paper copy.

We will not use the information for any other purpose than set out in this privacy notice and will not disclose to a third party i.e. other companies or individuals, unless we are required to do so by law for the prevention of crime and detection of fraud, or, in some circumstances, when we feel that you or others are at risk.

How long will we keep the information?

Further processing

Where and whenever necessary, we will seek your consent prior to the new processing.
