This privacy notice was completed in October 2022 and will be regularly reviewed. When we use your personal data, CYC complies with data protection legislation and is the registered 'Controller'. Our data protection notification is registered with the Information Commissioner's Office (ICO) – reference **Z5809563**.

Why is information being collected?

What information will be collected?

What will we do with the information?

The data we receive from this survey will be shared with colleagues working for City of York Council. The information we collect may be included in presentations, statistics and reports. Reports containing anonymous information may also be shared with the general public and other organisations.

We will protect it and make sure nobody has access to it who shouldn't and we will not keep it for longer than is necessary.
