

## **Privacy Notice for Provider Survey**

We keep our privacy notice under regular review and it was last reviewed and updated in September 2021.

We, Education Support Services, City of York Council (CYC) are the “Controller” and we are registered with the Information Commissioner’s Office (ICO) (General Data Protection Regulation (GDPR) and the Data Protection Act 2018) – reference Z5809563.

### **Why is information being collected?**

The Local Authority has a duty to ensure there are sufficient, high quality early years and childcare places to meet the needs of our families in York and this includes producing an annual early years and childcare sufficiency report. This survey has been developed by the Local Authority to help understand the current childcare situation across the city, including the impact covid-19 has had on provider sufficiency and whether the childcare needs of families in York are changing due to the current pandemic. Participation in this survey is voluntary and you may opt out of answering some or all of the survey questions.

### **Why do we need personal information from you?**

We only use your personal information with your explicit and informed consent for the purposes described/as set out in this Privacy Notice, in order to inform the childcare sufficiency analysis for the City of York area.

### **What information will be collected?**

We will collect information about your setting, including provision type, information on the number of places you are able to offer, potential sufficiency issues, charges, changes in demand and whether you are able to meet the childcare needs of all your families.

### **What will we do with the information?**

The data we receive from this survey will be analysed and the results used to inform our childcare sufficiency analysis and annual report. Data will be anonymised and will not identify individuals. We will not use the data for any other purpose than stated and will not disclose to a third party i.e. other companies or individuals, unless we are required to do so by law for the prevention of crime and detection of fraud, etc. Online data will be collected using SurveyMonkey.
