

## **Privacy Notice for Early Talk for York evaluation survey**

This privacy notice was completed in June 2022 and will be regularly reviewed. When we use your personal data, CYC complies with data protection legislation and is the registered 'Controller'. Our data protection notification is registered with the Information Commissioner's Office (ICO) – reference **Z5809563**.

### **Why is information being collected?**

The Local Authority has a duty to evaluate the work that it funds. This survey has been developed by the Local Authority to understand from professional stakeholders the effectiveness of the implementation to date of Early Talk for York. Participation in the survey is voluntary and you may opt out of answering some or all of the questions. ### **What information will be collected?**

We will collect information about your roles, your wider team or organisation, and your experiences and perceptions of Early Talk for York so far, including both quantitative and narrative data about your experiences.

Participation is voluntary and you can choose to not answer any of the questions.

### **What will we do with the information?**

The data we receive from this survey will be analysed and the results used to inform our project evaluation. The information we collect will be included in presentations, statistics and reports. Any presentations, reports and statistics for publication or use outside of the authorised council staff, will be anonymised and cannot be linked back to you, your family or individuals. Reports containing anonymous information may also be shared with the general public and other organisations.

We will protect it and make sure nobody has access to it who shouldn't and we will not keep it for longer than is necessary.

### **How long will we keep the information?**
