

## **Privacy Notice for Healthy Child Service “Home environment assessment tool-lite” parental/carer feedback survey.**

This privacy notice was completed in March 2021 and will be regularly reviewed. When we use your personal data, CYC complies with data protection legislation and is the registered ‘Controller’. Our data protection notification is registered with the Information Commissioner’s Office (ICO) – reference **Z5809563**.

### **Why is information being collected?**

A safe and suitable home environment is important for children to grow up in and the Healthy Child Service can support parents and carers with any concerns or issues related to home safety and suitability. To help us do that we are developing a home environment screening tool (called HEAT-lite). The Health Visitor will discuss the tool with all parents and carers the first time they visit as part of the Healthy Child Programme. We need parents and carers’ feedback to make sure the tool we develop is useful and acceptable and leads to meaningful support.

### **What information will be collected?**

We are collecting

- *your opinions and thoughts / your feedback*

Participation is voluntary and you can choose to not answer any of the questions.

### **What will we do with the information?**

We are using the information you give us with your consent. You can withdraw your consent at any time by contacting The Healthy Child Service [hcs-secure@york.gov.uk](mailto:hcs-secure@york.gov.uk) / 01904 555475. We will ask for your consent to send you a link by text or email to the survey.

The information we collect will be included in presentations, statistics and reports. Any presentations, reports and statistics for publication or use outside of the authorised council staff, will be anonymised and cannot be linked back to you, your family or individuals. Reports containing anonymous information may also be shared with the general public and other organisations.

We will protect it and make sure nobody has access to it who shouldn’t and we will not keep it for longer than is necessary.

We will not use the information for any other purpose than set out in this privacy notice and will not disclose to a third party i.e. other companies or individuals, unless we are required to do so by law for the prevention of crime and detection of fraud, or, in some circumstances, when we feel that you or others are at risk.

### **Storage of information**

We will keep the information you give us in CYC's secure network drive and make sure it can only be accessed by authorised staff.

### **How long will we keep the information?**

We will keep the information you give us for up to three years and then will securely and confidentially destroy it.

Where required or appropriate, at the end of the retention period we will pass onto the City Archives any relevant information.

### **Further processing**

If we wish to use your personal information for a new purpose, not covered by this Privacy Notice, we will provide you with a new notice explaining the purpose prior to commencing the processing and the processing conditions. Where and whenever necessary, we will seek your consent prior to the new processing.
