

## **Privacy Notice for York UK Shared Prosperity Fund Application Feedback Survey 2023**

This privacy notice was completed in February 2023 and will be regularly reviewed. When we use your personal data, CYC complies with data protection legislation and is the registered 'Controller'. Our data protection notification is registered with the Information Commissioner's Office (ICO) – reference **Z5809563**.

### **Why is information being collected?**

We want to hear about the experiences of the initial applicants to York's UK Shared Prosperity Fund. This feedback will help us understand if any adjustments need to be made to the application form for the next round of applications

### **What information will be collected?**

We are collecting

- extended (open-ended) responses that provide answers about the level of difficulty of the application form

Participation is voluntary and you can choose to not answer any of the questions.

### **What will we do with the information?**

We are using the information you give us with your consent. You can withdraw your consent at any time by contacting: [economicgrowth@york.gov.uk](mailto:economicgrowth@york.gov.uk).

The information we collect will be included in presentations, statistics, and reports. Any presentations, reports and statistics for publication or use outside of the authorised council staff, will be anonymised, and cannot be linked back to you, your family or individuals. Reports containing anonymous information may also be shared with the general public, and other organisations.

## **Storage of information**

We will keep the information you give us in CYC's secure network drive and make sure it can only be accessed by authorised staff.

## **How long will we keep the information?**

We will keep the information you give us for up to three years and then will securely and confidentially destroy it.

Where required or appropriate, at the end of the retention period we will pass onto the City Archives any relevant information.

## **Further processing**

If we wish to use your personal information for a new purpose, not covered by this Privacy Notice, we will provide you with a new notice explaining the purpose prior to commencing the processing and the processing conditions. Where and whenever necessary, we will seek your consent prior to the new processing.
