### Why is information being collected?

We get information about the enquiries received by Explore staff such as the volume and nature of enquiries and where the enquiries were signposted, directly from you via the online enquiry form.

#### What information will be collected?

We are collecting

- name of Explore venue
- date range of when the staff recording form refers
- nature of enquiry
- number of enquires per each enquiry type
- where the enquiry was signposted to

#### What will we do with the information?

We are using the information you give us with your consent. You can withdraw your consent at any time by contacting fis@york.gov.uk

The information we collect will be included in presentations, statistics and reports. Any presentations, reports and statistics for publication or use outside of the authorised council staff, will be anonymised and cannot be linked back to you, your family or individuals. Reports containing anonymous information may also be shared with the general public and other organisations.

## **Storage of information**

We will keep the information you give us in CYC's secure network drive and make sure it can only be accessed by authorised staff.

## How long will we keep the information?

We will keep the information you give us for up to three years and then will securely and confidentially destroy it.

Where required or appropriate, at the end of the retention period we will pass onto the City Archives any relevant information.

## **Further processing**

If we wish to use your personal information for a new purpose, not covered by this Privacy Notice, we will provide you with a new notice explaining the purpose prior to commencing the processing and the processing conditions. Where and whenever necessary, we will seek your consent prior to the new processing.
