# How do we get your information

# What personal data do we process and why

We will process

- How, how often and for what distance employees travel into work
- The barriers and incentives towards employees using low-carbon travel modes
- The habits of employees while working from home
- Your postcode, age, and disability status
- Any additional comments you have that are relevant to this topic

Participation is voluntary and you can choose not to answer any of the questions.

The council wants to engage with employees to understand more about their commuting and working from home habits. This will help City of York Council build on its Scope 3 carbon emissions data, improving our understanding of our operational emissions.

### Lawful basis for processing your personal data

We are using the information you give us with your consent. This means that any personal data including special category data that we process as part of this survey/consultation is done in accordance with Article 6 and 9 of the UK GDPR and Schedule 1 of the Data Protection Act 2018 (DPA 2018).

The legal basis for processing your personal data is in accordance with the following:

Article 6(1)(a) – your consent

The legal basis for processing your special category data is in accordance with the following:

• Article 9(2)(a) – your consent

Some of the Schedule 1 conditions for processing special category require an Appropriate Policy Document to be in place that sets out and explains the procedures for securing compliance with the principles in Article 5 and policies regarding the retention and erasure of such personal data. ### How long we keep your personal data

We will keep the information you give us for up to three years and then will securely and confidentially destroy it.

Where required or appropriate, at the end of the retention period we will pass onto the City Archives any relevant information.

We will keep the information you give us in CYC's secure network drive and make sure it can only be accessed by authorised staff

# **Data Sharing**

The information may also be included in presentations, statistics and reports. Any presentations, reports and statistics for publication or use outside of the authorised council staff, will be anonymised and cannot be linked back to you or individuals. Reports containing anonymous information may also be shared with the general public and other organisations.

We will not use the information for any other purpose than set out in this privacy notice and will not disclose to a third party i.e. other companies or individuals, unless we are required to do so by law for the prevention of crime and detection of fraud, or, in some circumstances, when we feel that you or others are at risk.

The Council does not pass or sell personal data to third parties for marketing, sales, or any other commercial purposes.

# Visiting our website and links to others

We are the sole owner of the information collected via our website. It does not store or capture personal data of users with general public access, but does log the IP address of a visitor. This enables us to determine which pages are being viewed and helps us to improve our services. It does not use cookies for the general running of the <a href="www.york.gov.uk">www.york.gov.uk</a> website, but does use them to enable requested services (for example, payments) and to remember choices during the visit. Anonymous information about page visits is collected using Google Analytics.

Our website privacy notice does not cover external websites; we encourage you to read the privacy notices on any other websites you visit.

Our website also lists email addresses for external organisations (those addresses that don't contain 'york.gov.uk'); we cannot guarantee what will happen to your personal data if you email an external organisation.

### Do we use any data processors

Where we use data processors who are third parties to provide elements of services for us, we have contracts in place with them. This means that they cannot do anything with your personal information unless we have instructed them to do it. They will not share your personal information with any organisation apart from us. They will hold it securely and retain it for the period we instruct.
