CIPFA Comparative Library Statistics 21/22


This report is being compiled a year after the end of 21/22 so it's worth recapping how services were effected by the pandemic at that time. At the start of 21/22 Explore had only three branches open with very reduced hours, no at-shelf browsing and no events. This turned around into a full offer within five months, but usage rose and fell throughout 21/22 as new variants emerged and customer confidence ebbed and flowed. Whilst all library services were tasked with the same broad challenge of providing for customers during a pandemic, decisions were made locally about when to re-introduce services like at-shelf browsing, PC use, and events. As such the 21/22 comparative statistics are not comparing authorities on a like for like basis in terms of the availability of services. Compared to other services, Explore tended to re-instate our offers swiftly as soon as it was safe and legal to do so, and therefore tended to be ahead of the national trend in progressing back towards pre-pandemic levels of use.

The figures in this report are based on data collected by CIPFA. Once again the number of English Unitary authorities submitting figures to CIPFA has fallen, so whilst we can still calculate our quartile position, we cannot state it with confidence. Of 55 Unitary Authorities, in most cases only 21 submitted figures, less than half of the unitary authorities for the first time, and a big drop from 40 authorities just a couple of years ago. Whilst some of this drop-off may be due to authorities feeling that pandemic figures are not comparable, the number of authorities taking part has been on a downwards trend for several years and may not bounce back.

Some of the measures which have been available in previous years (e.g. PC usage, footfall as busiest branches, and staffing levels) have not been released by CIPFA so do not form part of this report.


Physical Visits per 1,000 population

Whilst York's footfall is usually **upper quartile**, we would not normally expect to be an outlier as shown here. Some of the Unitary Authorities who typically get high footfall per population (e.g. Cheshire West; Windsor & Maidenhead; Thurrock) did not submit figures this year. As mentioned in the introduction, York were able to re-introduce services like events, at-shelf browsing, PC sessions and evening opening relatively early following the lockdowns, and our usage tended to be ahead of the trend accordingly: by the end of 21/22 York's footfall was 76% of our pre-pandemic levels whereas nationally (according to a small informal sample compiled by Libraries Connected) it was around 50%.



Book Issues per 1,000 population





eNewspaper, eMagazine, and eComic Issues per 1000 population


York's performance was upper quartile and indeed top, the PressReader service having been very well received since its launch in April 2020



York's performance is third quartile, up from lower quartile last year. York has always had a relatively small but hard-working book stock - we don't carry unpopular stock.



York's performance is **third quartile**. This is a very similar measure to the above, but with reference stock included. eBooks etc. do not form part of this measure.



York's stock breakdown is weighted slightly more towards Adult and less towards Children compared to UAs as a whole, but the difference is fairly slight.



York's performance was just above the median for this measure, **second quartile** This measure does not include acquisitions of eBooks, which was particularly pertinent in 21/22, only physical books



York's performance was **bottom quartile** for this measure, which includes only physical audiobooks not eAudiobooks.


Our audience have largely transitioned to borrowing eAudiobooks in preference to physical audiobooks, but there are still customers using physical audiobooks, some of whom have accessibility needs. Explore faces a challenge to allocate sufficient budget to both formats given the high price of these items.



Stock Turn

Stock turn is a measure of how hard the stock is working, average issues per item per year. In all cases our stock turn is considerably above the average across Unitary Authorities. It is not possible to calculate quartile positions for stock turn as CIPFA has not made the data available at authority level.


